The reason for this proposed amendment is to allow sufficient time to compile a complete report (including budget reports) for the congregation prior to the annual meeting.

Reason for the proposed amendment: The Lay Leadership Board seeks to provide a better form of notice for those members who do not use, or have access to, the internet, to provide a greater time period for notice, and to promote increased transparency. Also, when circumstances require the

LLB to act quickly, a special meeting may be called, and action can be taken on short notice. The minutes of any such special meeting, however, shall be accessible to the congregation following the meeting, and the congregation would still retain the power, as provided in Article 5 of the Constitution, to review, revise and revoke any power delegated to the LLB, if the congregation disagrees with the LLB's decision.

Reason for proposed changes: Sometimes exceptional circumstances arise, such as the Covid pandemic, which necessitate the need to amend or temporarily suspend strict provisions contained in the By-Laws. Adding this clause allows the Lay Leadership Board to quickly and efficiently respond to exceptional circumstances. The congregation will be notified of such action and shall retain the power to overrule such action, if the congregation so chooses.

23	1.	Call or removal of any Pastor or <u>removal of any</u> Called Worker.
24		Only such candidates shall be called and elected to serve as
25		pastor(s) (ministers of religion ordained) or as ministers of
26		religion commissioned as are eligible for a call in the Lutheran
27		Church Missouri Synod and profess acceptance of, and pledge
28		faithful adherence to, the Confessions of this Congregation as set
29		forth in Article 2 of its Constitution. Sufficient grounds for
30		removal of a Pastor or Called Worker shall be persistent
31		adherence to false doctrine, scandalous life, willful neglect of
32		official duties, or evident and protracted incapacity to perform the
33		functions of the office to which the individual has been called.
34		Charges on any of these counts shall be carefully investigated by
35		the Lay Leadership Board (the "LLB"). The LLB, after
36		consultation with the appropriate officers of The Nebraska

Reasons for this proposed amendment:

This amendment is proposed to grant the LLB authority to approve and extend calls to non-pastoral candidates. Currently, the congregation must hold a full congregational meeting to vote and approve every call extended to a non-pastoral candidate. With the ever-increasing rise in the number of non-pastoral called workers, this process has become burdensome and inefficient. Also, concerns have been raised that the Church may lose qualified candidates due to delays involved in the current lengthy process. Finally, under the proposed amendments, the congregation would still retain the power remove any called worker for cause and, as provided in Article 5 of the Constitution, to review, revise and revoke any power delegated to the LLB, if the congregation disagrees with the LLB's decision.

This amendment would allow the LLB Secretary extra time, if needed, to submit the meetings minutes for review and approval, but still requires that such submission be timely.
