Reasons for these proposed amendments:

This amendment is proposed to grant the Lay Leadership Board authority to approve and extend calls to non-pastoral called worker candidates. Currently, the congregation must hold a full congregational meeting to vote and approve every call extended to a non-pastoral candidate. With the ever-increasing rise in the number of non-pastoral called workers, this process has become burdensome and inefficient. Also, concerns have been raised that the Church may lose qualified candidates due to delays involved in the current lengthy process. Finally, under the proposed amendments, the congregation would still retain the power remove any called worker for cause and, as provided in Article 5 of the Constitution, to review, revise and revoke any power delegated to the LLB, if the congregation disagrees with the LLB's decision.

This Amendment passed during the 11/1/2022 Congregation meeting and passed District review. It passed LLB vote on 3/27/2023. It is ready for a second vote by the Congregation on 11/19/2023.
